Terms & Conditions:

1. Applicant may apply **online** within 30 days from the date of publication of advertisement.
2. All appointments shall be made in according with the prevailing Recruitment Rules/Policy of the Federal Government.
3. General five (5) year relaxation in age shall be admissible as per existing rules.
4. Age will be calculated with effect from the closing date of submitting applications.
5. A candidate can apply for more than one post by applying **online** separately for each post.
6. Applicant already in Government Service should apply through proper channel & produce NOC at the time of interview.
7. Incomplete applications /application received after due date shall not be entertained.
8. No TA/DA will be admissible for the purpose of test/interview
9. PNCU reserves the right to cancel the recruitment process in part or whole at any stage without assigning any reason.
10. Male/Female candidates can apply for all posts except Chowkidar at S.# 6. For Chowkidar only male candidates can apply.
11. Concealing the facts and any direct or indirect pressure for appointment would lead to be disqualification of the candidates. However, if any candidate is found ineligible he/she will be disqualified at any stage of the recruitment process. On the basis of merit, only eligible and short listed candidates will be called for test/interview.
12. All original documents (education, experience, domicile, CNIC etc.) will be examined at the time of interview.

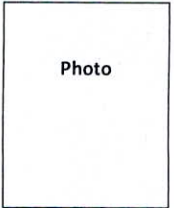
