INVITATION TO BID

The Ministry of Federal Education & Professional Training as the “Employer” invites sealed bids, under Single Stage-Two Envelope bidding procedure, from eligible firms or persons licensed by the Pakistan Engineering Council in the appropriate category for the Works. A foreign bidder is entitled to bid only in a joint venture with a Pakistani constructor in accordance with the relevant provisions of PEC bye-laws.

Conditions:

1. Application for issuance of Bids documents shall accompany the name, address(s), signature of contractor, valid enlistment / renewal of Firm with PEC & Completion certificate of similar nature of work done during last 3 years.
2. The owner of the Firm should submit the application and collect the Bid by himself. In case of authorized person, authority letter (regarding the particular work) in favor of the person deputed on the letter pad of the firm in required along-with copy of CNIC subject to verification from the original CNIC.
3. Bid Security in the shape of Call Deposit bearing Name of Firm in favor of “Deputy Director (HR/Admin, Program Coordination Unit, M/o FE & PT” from local scheduled Bank of Islamabad must accompany with the application of Price Bid. Cash / cheque will not be accepted.
4. If any contractor wants to participate in the Bid opening process through their representative, they should issue an authority letter on the letter head pad of the firm depicting complete valid address & contact numbers along with attested copy of CNIC.
5. The contractor will submit the documents as per instructions of Bid documents along with their Bid, without which proposal will be liable for rejection.
6. PEC Certificate & Professional Tax Certificate in original will be seen at the time of opening of Bids.

7. The Employer may reject all bids or proposals at any time prior to acceptance of bid or proposal. The Employer shall on request communicate with any supplier or contractor who submitted a bid or proposal but is not required to justify those grounds. Conditional incomplete or telegraphic bids shall not be accepted.
8. The Pre-Bid meeting for the purpose of clarifying issues and answering questions on any matter that may be raised will be held on 29-5-2023 at 3:00 pm. Venue will be at the Deputy Director (HR/Admin, Program Coordination Unit, M/o FE & PT, Ground Floor, Pakistan Manpower Institute, Khayaban-e-Suhrwardy, G-7/1, Islamabad. Queries, if any, should be sent through registered courier service before the pre-bid meeting.

10. Canvassing in connection with Bids is strictly prohibited. All bidders must fill in a check list before submission of bid in their own interest as per section-G of Instructions to Bidders which is a mandatory requirement.
